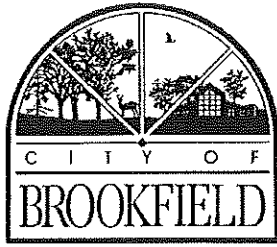

Meeting Minutes

New Business

Item 2 2017 Highway Statistics report

Alderman Blackburn asked about the traffic crashes following installation of the overhead LED stop signs at Gebhardt Road and Brookfield Road. Mr. Grisa indicated he will request accident reports after the light has been in place for three years. There have been no complaints about the LED lights. Mr. Hughes stated he has not received any calls to clean up crash debris at this site.

Alderman Blackburn noticed tree removal increased. This is due to Emerald Ash Borer tree removal.

Alderman Owen questioned the 30% reduction in cost at the recycling center due to restricting contractors. Mr. Grisa stated to review page 33 where it indicates it is a 30% reduction in volume.

Alderman Berg asked if there was any data on lost time due to injury or staff not replaced after retirement. Mr. Hughes stated there have been no on-the-job injuries in 2017.

Alderman Owen questioned the necessity of street sweeping. Mr. Hughes indicated the demand for sweeping is far less now that the City is only using salt on the streets and no sand, but there is still debris on the streets that should be removed.

Motion by Alderman Blackburn, seconded by Alderman Carnell to approve the 2017 Highway Statistics report. Motion carried 5-0.

Item 3 Award of the 2018 Annual Road Resurfacing project

Motion by Alderman Jurken, seconded by Alderman Carnell to approve the award of the 2018 Annual Road Resurfacing project. Motion carried 5-0.

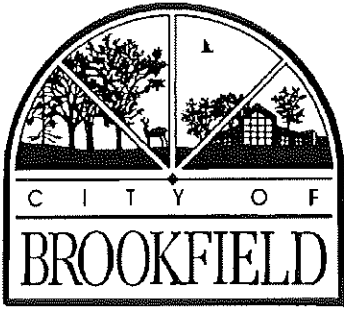
Item 4 Proposed electrical service easement across the Pleasant Street Public Parking lot to serve 18760 Pleasant Street

SUBJECT: Bus stop addition from Milwaukee County Transit System

DATE: April 6, 2018

Staff received a request from Milwaukee County Transit System (MCTS) to add a bus stop at Wirth Street near N. 126th St. as part of Route 60. They have had requests for this stop which will serve this industrial park on the east side of Brookfield.

It should be noted that staff has administrative authority to issue a permit for this request to install a bus stop sign in the right of way, but we are bringing this item to the Board for consideration.

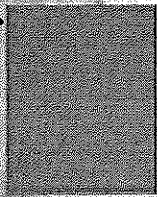
There are no sidewalks at the proposed bus stop location on Wirth Street but this would not be the only location where MCTS has stops on roads without sidewalks. In fact, bus stops occurred on N. 124th Street in Brookfield where no sidewalks existed, until the City recently constructed them.

Staff recommends approval of this request.

bus stop

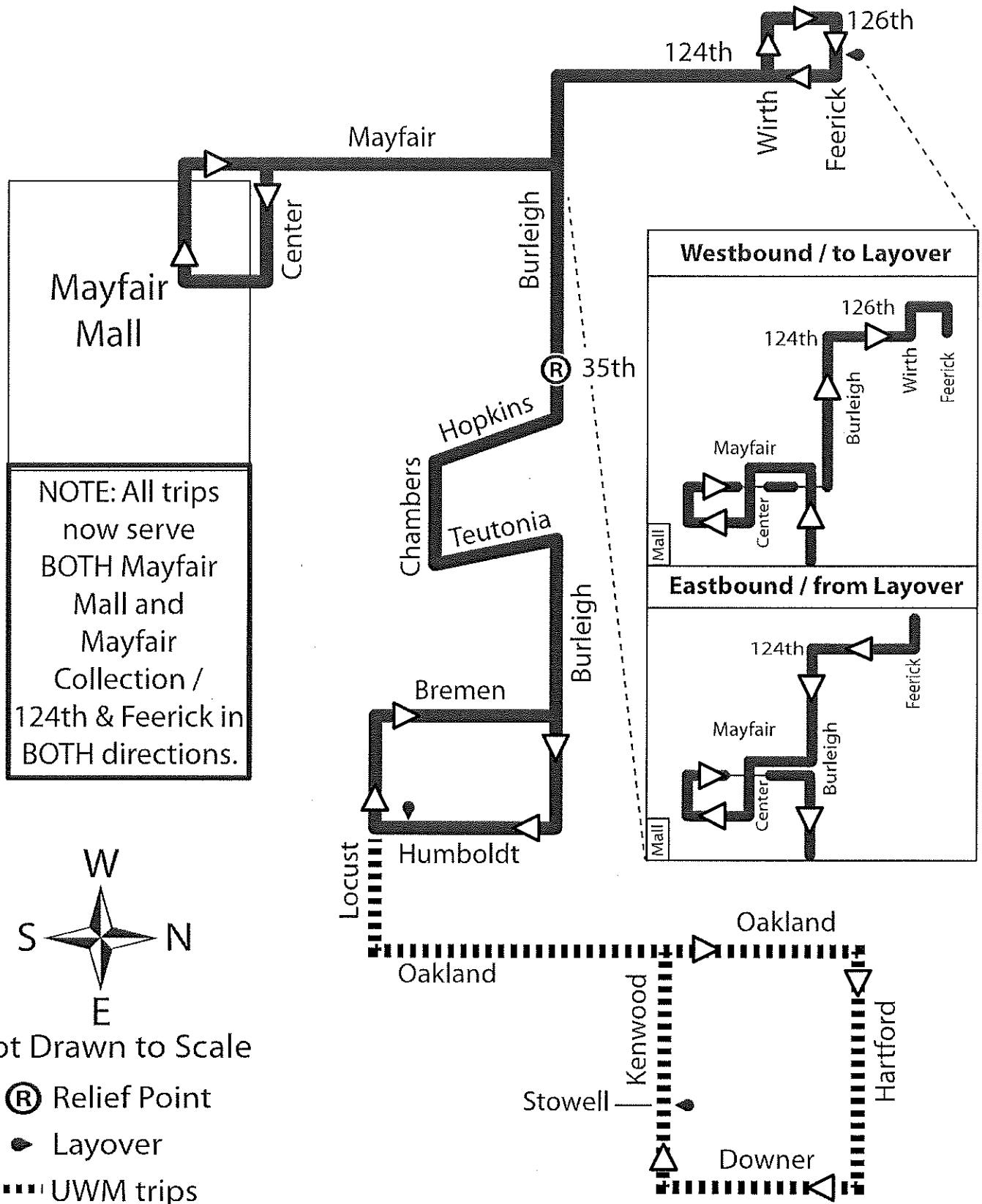


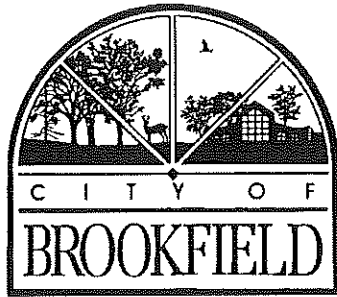

Rationale: This project consists of the repair and replacement of concrete curb and gutter and storm catch basins and inlets. Through this project, the City will remove and replace 1,085 lineal feet of curb and gutter, repair approximately 5 storm inlets, remove and replace 800 square feet of sidewalk.

Recent Contractor Work History: T.P Concrete has constructed Curb and Gutter worked in the City past 15 years. Staff did have a positive working experience with this contractor, who has proven to be capable of performing this type of work.

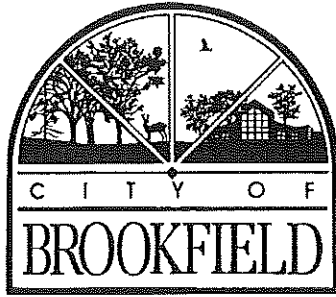
