



MINUTES OF A **REGULAR COMMON COUNCIL MEETING OF THE 32ND COMMON COUNCIL HELD AT 7:45 P.M., TUESDAY, FEBRUARY 6, 2018, IN THE COUNCIL CHAMBERS OF BROOKFIELD CITY HALL, 2000 N. CALHOUN ROAD, BROOKFIELD, WISCONSIN**
