



MINUTES OF A **REGULAR COMMON COUNCIL** MEETING OF THE 33rd COMMON COUNCIL HELD AT **7:00 P.M.**, TUESDAY, **APRIL 17, 2018**, IN THE COUNCIL CHAMBERS OF BROOKFIELD CITY HALL, 2000 N. CALHOUN ROAD, BROOKFIELD, WISCONSIN

Mayor Ponto called the meeting to order at 7:00 pm.

CEREMONIAL SWEARING-IN: Introduction and swearing-in of re-elected Mayor Steven V. Ponto, Aldermen Bill Carnell, Bob Reddin, Jeff McCarthy, Mark Nelson, Gary Mahkorn, Jerry Mellone and newly elected Alderman Brad Blumer by Municipal Judge Jeff Warchol.

Mayor Ponto gave the following statement: “When I first ran for Alderman in 1998, which is now 20 years ago, I often said to people, if government is to work anywhere, it should work in Brookfield. Brookfield to me has always been and is now, a special place, a premier city, blessed with a very talented and fair minded population. We have so many advantages. It is a privilege for me and for each of the Aldermen to represent this community as its elected representatives. We will do our best to be worthy of the trust that has been placed in us. The professional resident survey which was conducted last year by Cobalt Community Research shows that our residents have a very favorable view of the city government. Satisfaction with the city government was higher even than satisfaction with the community as a whole. Particularly noteworthy was that satisfaction with the city government was 30 percentage points ahead of satisfaction with the state government. I must note also that, with this spring election, it has now been 12 years since an incumbent Brookfield Alderman was defeated in a bid for re-election. This suggests to me that most residents approve of the direction of our city government. With this swearing-in ceremony, we now have the 33rd Common Council and I continue to be the 5th Mayor in the history of the City of Brookfield. I call upon all of us elected officials to unite in our service to Brookfield. That doesn’t mean that we will always agree on everything; but if we disagree, it must be with mutual respect and tolerance. Fundamentally, we must always strive to be worthy of the community that we represent. We will seek to cooperate with other governmental entities to provide even better services to our residents at a lower cost. We will work with others to promote Waukesha County, the Milwaukee Metropolitan Area and the State of Wisconsin. We will at the same time vigorously represent the interests of this City to other local governments, to Waukesha County and to the State government. For me, I thank the citizens of Brookfield for again giving me the opportunity to serve as your Mayor. This is truly what I most want to do at this point in my life. As I said when I was first elected Mayor in 2010, I will do the very best I can. I will not let you down. Thank you.”

A moment of silence was held to honor former First Lady Barbara Bush who passed away this evening.
