PART I. Subsection 8.08.190 of the Municipal Code, the schedule of fees relating to fire protection and Life Safety is hereby repealed and recreated to read as follows:

8.08.190 Permit fees.

A. Fire protection systems, to include but not be limited to, smoke, heat and manual fire alarm systems:


PART II. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.
