HERE IS A LIST OF THE MOST OFTEN ASKED QUESTIONS AND ANSWERS REGARDING GARDEN HOUSES

Q: How much does a garden house permit cost?

A: The garden house permit fee is \$61.00.

Q: Do I need plans?

A: Yes. If you are buying a manufactured unit, the brochure will suffice as a plan. Also, please submit two copies of the brochure and five copies of a current **SURVEY** of your lot showing where the garden house will be placed. A garden house must be placed 20' from the rear and side lot lines and 10' from all other buildings and a hold harmless agreement must be signed in order to use a survey over one year old. You may place the garden house 5' from the side and rear lot lines if using a survey that is no older than 1 year (at the time of application).

Q: Does it have to be built on a concrete slab?

A: Yes. Minimum concrete thickness required is 3" of concrete on 6" of sand or gravel.

Q: Can I put it next to my house/attached garage?

A: You must maintain at least 10'0" from any part of your house/garage to any part of the garden house.

Q: Does it have to be in the rear yard?

A: Yes. For citizens with through lots (streets in the rear) or corner lots check with Inspection office. **Garden houses are not permitted in easements. (Hold harmless agreement may be required)**

Q: Do I need to provide any landscaping?

A. Yes. The garden house must be screened from view from the street and interior lot lines with bushes or other adequate foliage at least 3' in height at time of install (to reach at least 6') and must be drawn on the survey upon submittal.

Q. Are there construction standards for garden houses?

A. Yes. Garden houses must be built to the general established standards of the Uniform Dwelling Code and shall have exterior roof and siding finishes that are compatible with the primary structure on the subject lot and neighboring properties. **Metal, resin, plastic or vinyl structures are NOT permitted.**

Q: How big can I build it?

A: 10'6" is the maximum overall height allowed. The area limitations are as follows:

| Lot Size | Maximum Garden House Size |
|-------------------------------|---------------------------|
| Less than 12,000 square feet | 120 square feet |
| 12,000 square feet or greater | 180 square feet |

NOTE: The property owner is responsible for correct placement of structures upon a parcel of land to comply with the building and zoning law.

The edge of the City street pavement or back of curb is usually **NOT** located on a property line.

Length/width ratio shall not exceed 2/1 maximum.
EXAMPLE: 8'x16' or 9'x18' do not exceed 2 to 1 rule.
